SUMMARY OF RECENT ACCOMPLISHMENTS!

- ❖ **Research:** GLOBAL's advocacy, and our research at the Crnic Institute and the Alzheimer's & Cognition Center, resulted in the first NIH National Down Syndrome Data Coordinating Center, the first clinical trial to treat immune conditions specifically for those with Down syndrome, the first clinical trial to address Down Syndrome Regression Disorder, and the first clinical trial to test a promising Alzheimer's drug in young adults with Down syndrome.
- ❖ **Medical Care:** Our Sie Center for Down Syndrome at Children's Hospital Colorado provided excellent medical care for 2,500+ children with Down syndrome from 33 states and 10 countries. Our Adult Clinic at Denver Health is seeing over 220 patients. GLOBAL and the American Academy of Pediatrics established a long-term collaboration resulting in the translation of their important guidelines for children with Down syndrome. In addition, the GLOBAL Adult Guideline, the first evidence-based medical care guidelines for adults published in *JAMA (Journal of American Medical Association)*, is now available in English, Spanish, Japanese, Italian, Albanian, and Swahili.
- ❖ **Lobbying and Advocacy:** Our advocacy efforts include the introduction of the transformational DeOndra Dixon INCLUDE Project Act which if passed will result in more permanent increased funding for Down syndrome research at NIH. Over the last seven years, we have generated an additional \$440 million in NIH Down syndrome research and medical care – We are grateful to our Congressional champions, self-advocates, and friends at the NIH!
- ❖ **Be Beautiful Be Yourself Fashion Show:** We celebrated our 16th anniversary of our award-winning event on November 16, 2024, honoring Quincy Jones Awardees Woody Harrelson and Sofia Sanchez, Ambassador Zaya Biel, 18 gorgeous models, and hosting 1,500 attendees.
- ❖ **AcceptAbility Gala:** Last May, GLOBAL held its annual AcceptAbility Gala, DC's largest fundraiser for people with Down syndrome. Representatives Lois Frankel (D-FL) and Richard Hudson (R-NC) received GLOBAL's highest honor, the Quincy Jones Exceptional Advocacy Award, for their strong advocacy in Congress on behalf of people with Down syndrome. GLOBAL awardee alumni, Representative Cathy McMorris Rodgers (R-WA), and Representative Rosa DeLauro (D-CT) provided keynotes and introduced the night's honorees. [Click here for highlights.](#)
